I. Report on the Audit of the Standalone Financial Statements

Opinion

We have audited the Financial Statements of **YAASHVI JEWELLERS PRIVATE LIMITED** ("the Company"), which comprise the balance sheet as at **31st March 2023**, and the statement of profit and loss, and statement of cash flows for the year then ended, and notes to the Financial Statements, including a summary of significant accounting policies and other explanatory information [hereinafter referred to as "the Financial Statements"].

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Financial Statements give the information required by the Companies Act, 2013 in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at **March 31, 2023**, and its profit/loss, and its cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit of the Financial Statements in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Financial Statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the Financial Statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Those Board of Directors are also responsible for overseeing the Company's financial reporting process.

- (i) Planning the scope of our audit work and in evaluating the results of our work; and
- (ii) to evaluate the effect of any identified misstatements in the Financial Statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

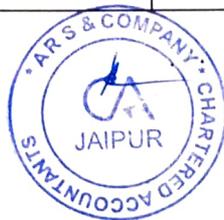

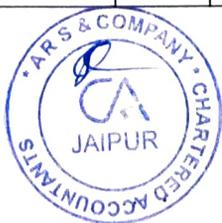

1 SIGNIFICANT ACCOUNTING POLICIES :

- a) **Accounting Convention:** The financial statements are prepared on historical cost convention and on the basis of going concern.
- b) **Accounting Policies:** The management is consistent in following the accounting policies, there is no change in the same.
- c) **System of Accounting :** The management has followed the accrual system of accounting except in case of expenses of small amount (not having material impact), which are accounted for on paid basis.

2. Fixed Assets and Depreciation:

- a) Fixed assets are stated at cost of acquisition inclusive of freight, direct expenses, taxes (if input tax credit of same has not been availed under the provisions of the respective Act) and expenses incidental thereto.
- b) Depreciation is provided on the basis of WDV method in accordance with the rate prescribed in Schedule II, Companies Act,2013.
- c) The relevant disclosure regarding to fixed assets is given in form no. 3CD.

4. Valuation of Inventories:

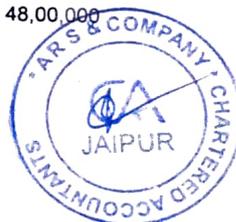

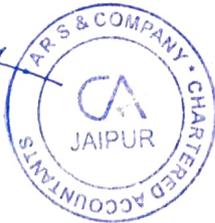
